The purpose of this notice is to provide you with information regarding a change in reporting requirements within the Client Information and Registration Tracking System (CIRTS) for individuals receiving services through the National Family Caregiver Support Program, Older Americans Act (OAA), Title IIIE. This is due to changes in reporting required by the U.S. Department of Health and Human Services, Administration on Aging. (This reporting change is effective January 1, 2009.)

All individuals receiving services through Title IIIE must be actively enrolled in CIRTS for the program in which the services are funded, within Caregiver Support Services (OAAIIIE), Services to Grandparents (OAAIIIEG) and Supplemental Services (OAAIIIES). The attached chart notes all funded services within these programs and the reporting requirements for each service in CIRTS. Services provided individually will require monthly aggregate reporting by client in CIRTS. Services provided in a group setting, with the exception of counseling, will maintain the requirement of monthly aggregate reporting in CIRTS.

Each OAA IIIE Provider and staff will be responsible for entering the required service data into CIRTS. Monthly aggregate reporting <u>by client</u> in CIRTS begins with services provided as of January 1, 2009.
