SUBJECT: 2016 NPCR Tool Update

The purpose of this memorandum is to provide the revised Quarterly Nutrition Program Compliance Review Form (NPCR). The NPCR is to be used when conducting quarterly meal site reviews. This form replaces the current 2010 version.

Meal site reviews must be conducted quarterly at each physical meal site location. The NPCR must be used for this purpose and reviews must be conducted as follows:

- Once per year by the nutrition consultant (licensed dietitian or licensed and registered dietitian),
- Once per year by the nutrition program service provider's administrative staff member, and
- Twice per year by the meal site manager or designee.

Thank you for your cooperation and assistance in implementing the updated NPCR Tool.

Complete this form quarterly at each meal site. It must be completed once per year by: 1) A nutrition consultant (licensed dietitian or licensed and registered dietitian) and 2) A nutrition program service provider's administrative staff member.
