SUBJECT: Notice of Instruction: New CIRTS enrollment codes

Per the Department of Elder Affairs' Notice of Instruction #:092905-1-I-SWCBS, three new client enrollment program status codes have been added to CIRTS. These codes allow the tracking of individuals who choose to enroll in the LTC Community Diversion Pilot Project (also known as the Nursing Home Diversion Waiver) under the following situations:

- (1) while waiting for non-NH Diversion Waiver services
- (2) while having their eligibility determined for the Aged/Disabled Adult Services Medicaid Waiver (ADA) or Assisted Living for the Frail Elderly Medicaid Waiver (ALE), or
- (3) while active in a program other than the NH Diversion Waiver.

The new client enrollment program status codes (all end in "ND") are as follows:

- TAND: Terminated APCL Chose NH Diversion Waiver
- TPND: Terminated APPL Chose NH Diversion Waiver
- TRND: Terminated Client Transferred to NH Diversion Waiver

A full list of CIRTS program status codes used with the ADA and ALE waivers are as follows:
